Steve Smith, Director of Public Works, called the meeting to order at 6:00 p.m.. He introduced Michael Hoffman and Rayferd Colburn representing AAA Asphalt and Paving, the contractor who was awarded the bid for the Strey Lane Drainage and Improvement Project. He also introduced Ed Conger and Greg Osborne of Klotz Associates, the engineering firm who did the design of the project.

The purpose of the meeting was for the residents to ask questions of city staff, the city engineer, and the contractor. Even though the entire city council was present, there was no deliberation or any formal action by the governing body of the City of Bunker Hill Village.

Mayor Essary summarized the need for the drainage improvement and explained how it is being funded.

Mr. Smith stated the cost of the project is \$5,127,500 and is expected to be completed in 330 days. After a brief discussion of the project, residents in the audience were invited to ask questions of the city, the engineer and the contractor.


